

NEW COURT REPORTER RATES

JUSTICE ADMINISTRATIVE COMMISSION

The General Appropriation Act (HB 5001) includes changes to the state-funded rates for court reporter billings. Starting July 1, 2024, JAC will apply the new rates to billings submitted with <u>Orders</u> signed on or after July 1, 2024. For Billing purposes, the new rates will be applied based on the signed <u>Court Order Authorizing Services, with</u> the exception of Appearance Fee billings.

<u>Appearance Fee Billings</u>: The rate of service will be based on the <u>Date of</u> <u>Appearance</u>. Any Date of Appearance on or after July 1, 2024 will be processed at the new rates.

<u>**Transcription/Listening Fee/Video Services Billings</u></u>: For these billing types, the rate of services will be based on the <u>Signed Court Order**</u>, regardless of when the attorney request the transcript from the court reporter. Please see the below scenarios to assist you with billing practices.</u>

First deposition taken 6/15/24 and continued or no show Second deposition taken 7/15/24. Order authorizing transcripts entered on 7/15/24 Appearance fee for first deposition – old rate Appearance fee for second deposition – new rate Transcript rate – new rate
