Attached is a Payroll Deduction Authorization Form for employees who wish to purchase season football tickets. To be eligible for payroll deduction, the Athletic Ticket Office is requesting a copy of each employee's completed payroll deduction form prior to receiving payment. Therefore, these forms should be returned to JAC Post Tax Benefits by the close of business Friday, March 9, 2018.

Since FAMU must receive the total price of the tickets by June 30, 2018, payroll deductions for tickets will be authorized for four (4) equal deductions beginning with the warrant pay date of March 30, 2018, and ending on the warrant pay date of June 29, 2018.
