All state group health insurance enrollees and their dependents can now use the new online transparency portal through Healthcare Bluebook and the bundled surgical services benefit offered through SurgeryPlus. Enrollees and their dependents are automatically enrolled and can access the benefits on a voluntary basis at no cost.

Enrollees and their dependents who use these benefits may receive a share of the savings they generate through financial rewards deposited into a saving and spending account of their choice. Enrollees can select an account or change their account selection any time in People First.
