OPEN ENROLLMENT
March 1 through March 31, 2015**

Reliance Standard Life Insurance Company is offering another opportunity for you to participate in their Voluntary Life Insurance program.

This insurance is available to all active full-time employees who are working at least 30 hours per week. Important plan features include:

- Family Coverage - Insurance coverage is available to you, your spouse and dependent children.
- Living Benefit - The plan provides a Living Benefit Rider if you or your insured family member(s) should become terminally ill and meet all the requirements. The advance payment is equal to 50% of the insured's coverage, up to \$250,000.
- Guaranteed Issue - The amount coverage available to you without answering any medical questions during the open enrollment is \$10,000. If you have reached the plan's \$100,000 guaranteed issue limit, are under age 60 and have been insured for 6 months,

you are eligible for an additional \$10,000 during each open enrollment period until your coverage equals \$150,000.

- Maximum Coverage - The maximum amount of coverage available to you or your spouse is \$500,000. You and your spouse will need to answer medical questions for coverage above the Guaranteed Issue amount.
- Portability - If you leave the department you may continue your group coverage or convert to an individual permanent life insurance policy.
