To be eligible for payroll deduction, the Athletic Ticket Office is requesting a copy of each employee's completed payroll deduction form prior to receiving payment. Therefore, these forms should be returned to JAC Human Resources by the close of business Wednesday, March 15, 2017.

Since FAMU must receive the total price of the tickets by July 31, 2017, payroll deductions for tickets will be authorized for four (4) equal deductions beginning with the warrant pay date of March 31, 2017, and ending on the warrant pay date of June 30, 2017.
