SUBJECT: Life Insurance of North America – Long Term Disability

DATE: August 28, 2017

Life Insurance Company of North America (LINA), a Cigna Company Long Term Disability Insurance *Awareness Period* September 1 – October 31, 2017

The LINA Long Term Disability Plan is designed to help replace your income in the event you are disabled and unable to work due to sickness or accident, with a benefit of up to 2 years for sickness and 5 years for accident.

All eligible employees are now able to enroll in the program year-round. OPS employees are not eligible. If you are currently enrolled, the **awareness period** (September 1 – October 31, 2017) is the time to change your waiting period or to adjust coverage based on your current salary. Employees classified as SMS/SES may want to consider lengthening their waiting period due to the short-term disability coverage provided by the State for such employees.

Important note for current participants: the LTD rates are age-banded; therefore, premiums will change for employees who have upgraded to a different age group.
