The Justice Administrative Commission would like to announce that nominations for the 2018 Prudential Productivity Awards (formerly "Davis Productivity Awards") will open September 4, 2017. Applications will be accepted only until October 16, 2017. Materials to assist you in submitting a nomination are being provided to you as separate attachments. If your office wishes to submit a nomination, please designate an individual to serve as your office's Coordinator.

This government improvement initiative co-sponsored by Prudential, Florida TaxWatch, and the State of Florida is dedicated to recognizing and rewarding employees for their achievements and innovations in state government. If you know of an individual or team who has made measurable achievements in productivity, quality improvements, public policy, or long range program development, you may wish to nominate them.

For those of you who may not have submitted a nomination in the past, here are the basics:

- You may nominate yourself, a colleague, a team of up to 8, or a whole department/agency for an award.
- Winners are typically those nominations that show innovation, a clever approach to a problem, significant taxpayer savings, and/or dramatically improve service delivery.
- Keep in mind, cost saving estimations and FTE reductions will need to be verified by Florida TaxWatch staff, so please be sure that you have documentation where appropriate.
- Nominators are allowed to upload supporting documents along with the nomination. This can be an official letter from your agency head affirming the achievement or endorsing

the nomination; or cost savings calculations; or even news clippings showing public recognition of the achievement. Anything that might show why your nomination deserves a top award.
