Dear Colleagues,

On Monday, November 14, 2016, the U.S. Citizenship and Immigration Services (USCIS) department issued the new I-9 Employment Eligibility Verification form. Agencies must transition from the previous edition, which had an expiration date of 03/08/2013, to the new version. The new version includes a number of changes in both wording and formatting, but the most significant change is that the form may now be accessed and filled out electronically before printing the document. Using the new electronic functionality is not required as employers still have the option of printing out the form and completing it entirely by hand. The expiration date on the newly released form is 08/31/2019. Agencies have until January 21, 2017 to transition to the new form. After January 21, 2017, all previous versions of Form I-9 will be invalid and may no longer be used for new hires.
