Depositions allowed in capital cases only

In all other cases, depositions shall be recorded on tape only	
Videographers may be arranged through Court Administration

\$50 minimum fee per session for morning or afternoon, but only one minimum fee will be paid per day	
Hours over 8 per day will be paid at 1.5 times regular rate	
<i>Videography rates (capital cases only):</i>	
First hour	\$100.00
Per half hour thereafter	\$25.00
<i>Notes:</i>	
\$50 minimum fee if cancelled less than 2 hours before scheduled start of depo but before equipment set up	
\$100 minimum fee if cancelled less than 2 hours before scheduled start of depo but before equipment set up	
Attendance time ends when equipment has been taken down

<i>Items requiring prior court approval <u>with</u> notice to JAC:</i>	
Overnight stays	
Portal-to-portal hourly travel charges	
Incidental travel expenses or rental car charges	
Fees in excess of the above rate and caps	
Services must be billed within 30 days of date rendered, or at the conclusion of the case, whichever is earlier	
Services should be provided by investigators with the State Attorney or Public Defenders offices, absent a conflict of interest
